Welcome to the largest AI Pimp empire on Base — a clean, SFW-first gallery of AI-generated images with crypto-native incentives. This document outlines the vision, tokenomics, roles, incentives, and roadmap.

Vision & Ethos

We reward creation, curation, and commitment. The playful “pimp” theme drives community identity but safety and respect are non-negotiable. Every pimp eats: creators, gatekeepers, stakers, boosters, and holders.

Chain & Token

Chain: Base mainnet (Ethereum L2). Token: \$PIMP ERC-20, no transfer taxes, non-pausable, EIP-2612 permit-enabled. Uses: rewards, staking, boosting, access-gating VIP galleries.

Supply & Allocations

Fixed supply: 1,000,000,000 \$PIMP. Community rewards: 45%. Staking emissions: 25%. Ecosystem/Treasury: 20%. Team: 10% linear vesting with public schedule.

Roles & Rewards

Creators — 300 \$PIMP per approved upload (daily cap). Gatekeepers — 30 \$PIMP per review, up to 9,000/day (overtime until 30 spots filled). Stakers — single-pool emissions with tiered APRs; Kingpin tiers. Boosters — spend small \$PIMP to rank content on-chain. Holders — unlock VIP galleries via wallet check.

Launch Waves

Wave 1 (First 20–30): Triple APR; Kingpin unlock at 200k; lifetime access to three favorite models; overtime until 30 spots filled. Wave 2: Double APR; Kingpin unlock at 300k; lifetime access to two models. Standard: Baseline rewards continue.

Quality Guidelines

SFW-only. No explicit content, hate, or illegal material. High-quality means sharp rendering, good composition/lighting, tasteful styling. Free or paid generators are fine—quality wins.

Website Features

Age gate, VIP holder gating, boost ranking (tiny \$PIMP spends), Transparency Board (supply, burn, treasury, staking TVL, emissions), and permit-enabled UX where feasible.

Staking (Single Pool)

Non-custodial staking with emission schedule and tiers. Read functions power the Transparency Board. No taxes, no pause function to reduce attack surface.

Boost Contract

Records on-chain Boost events (imageld, booster, amount, timestamp). Frontend indexer aggregates into rankings; parameters governed publicly (timelock after launch season).

Deflation & Treasury

Optional trickle-burn via governance; treasury for audits, ops, grants, infra, marketing. Multisig approvals and public receipts.

Security & Audits

Static analysis (Slither/Mythril/MythX), external audits before upgrades, bug bounties, multisig key management. Transparency Board for constant oversight.

Roadmap

Phase 0: Community bootstrap (Twitter/Telegram), landing live. Phase 1: \$PIMP deploy on Base, staking live, Transparency Board. Phase 2: Creator/Gatekeeper onboarding and tools, Boost contract. Phase 3: VIP galleries + profiles/collections. Phase 4: Governance handoff and seasonal campaigns.

\$PIMP is a utility token, not an investment contract. No guarantee of profit. Users must follow local laws and maintain wallet security. The brand's playful voice never overrides safety: SFW content only, age-gated access, rapid removal of violations.
